

## **KIBB – BOB’S “Trucks & Bucks” Contest with the Kansas Lottery August 2017**

### **1. PROMOTION DATES**

The on-air KIBB “Trucks & Bucks” (Promotion) will begin on August 7, 2017 at 6 a.m. CT and ends August 18, 2017 1 p.m.

KIBB on air (commencing 8/7/2017):

HOW TO PLAY-Listeners will be instructed to listen weekday mornings at 7a.m for the announcement of the TRUCK song of the Day. The contest will happen weekdays (M-F) during the noon hour (12:00-1:00p). When the song plays phone lines are opened up for contestants. Caller 10 at (316) 425-3344 will win \$30 in lottery scratch tickets. Each daily winner will be entered in the Grand Prize drawing for a chance at \$100 in lottery scratch tickets. Winner of the Grand Prize will be chosen at random on August 18, 2017.

### **OFFICIAL CONTEST RULES**

**For KIBB-FM hereinafter referred to as the “Station”**

*Note: These rules apply generally to all contests, unless contest-specific rules are posted on pages related to that contest.*

#### **1. The Contest**

a) Contest dates vary from contest to contest.

b) The Station, owned and operated by Connoisseur Media, LLC (CONNCOS) may terminate contest at any time or change dates and locations in its sole and absolute discretion

#### **2. Entry / How To Win / Eligibility**

a) Method of entry and determining winners varies from contest to contest.

b) Contestants listening to the Station via the internet stream are advised that there is a delay between the time the cues to call are made on the air and when they are heard over the internet and therefore will be at a disadvantage over those contestants listening over the air. Listeners to the online stream may not be able to timely participate in any station-conducted on-air contests. Due to this delay in the Station's streaming broadcast, listeners to the online stream are encouraged to listen to the Station live on-air.

c) No purchase is necessary.

d) Odds of winning will depend on the number of qualified entries. Individuals may qualify more than once.

e) Contest is open to all legal U.S. residents. All employees, agents, successors, interns and assignees of Connoisseur Media, LLC, sponsors of this contest, employees of competing radio stations and members of their immediate families or households are ineligible. The term "immediate family" includes spouses, siblings, parents, children, grandparents and grandchildren, whether as "in-laws" or by current or past marriage(s), remarriage(s), adoption, cohabitation or other family extension and any other persons residing at the same household whether or not related. Participants and winner(s) must be U.S. residents.

f) No "duos", groups or teams will be allowed to enter together. Any ties, disputes, conflicts, questions or concerns regarding the Contest and/or the prize(s) will be determined by CONNCOS, whose decision(s) is final.

g) Participants are restricted to the use of ordinary telephone equipment. Participants that enable the "Caller ID" block function may not be allowed to participate unless they enter their correct area code and telephone number. CONNCOS disclaims all liability for the inability of a participant to complete or continue a telephone call due to equipment malfunction, busy lines, inadvertent disconnections, acts beyond CONNCOS' control, or otherwise. Any valuation of the prize(s) awarded is based on available information provided to CONNCOS, and the value of any prize(s) will be determined by CONNCOS, in its sole discretion.

b) It is anticipated that qualifiers should have possession of their qualifying prize within 80 days of winning, however, CONNCOS makes no guaranty as to the actual delivery date.

c) All Contest(s)/Prize(s) are subject to Federal, State and local regulations and laws and are void where restricted or prohibited by law. Promotion is governed by U.S. law and is void outside the United States.

#### **4. Conditions of Winning**

a) Each winner must provide Station with valid identification and a valid taxpayer identification number or social security number before any prize will be awarded. Failure to timely provide such information and/or any other reasonably required documentation including, without limitation, a release and affidavit of eligibility, may result in a delay in receiving prize(s) or the forfeiture thereof. Stations will disqualify any entry from individuals who do not meet eligibility requirements.

## **6. Indemnity**

a) All participants and winners, agree and do hereby indemnify and hold forever harmless CONNCOS and their agencies, their agents, officers, employees, affiliates and assigns for any injuries, accidents, misfortunes, losses, damages or causes of action arising from or in connection with participation in the Contest and/or acceptance or use of any prize(s).
